Dear Chairperson,

I have the distinct pleasure of nominating my friend and colleague, David T. Haresign, FAIA, for the 2021 Centennial Medal. David has been a respected and energetic member of the Washington architectural community throughout his 45 plus years of practice and has clearly made – and continues to make - substantial contributions to the profession and the community. In addition to co-founding a successful and socially responsible firm, he is a tireless contributor to the Chapter, nonprofit organizations, and academia. David is a colleague, confidant, and trusted advisor to many – plus a person to call upon when a need arises and action is required. Always generous with his time and money, David epitomizes the spirit of the Centennial Medal though his life of service.

While I had known David socially for a over 25 years, I first was able to fully understand and experience his passion for service to the profession during our years of service together on the AIA|DC Chapter Board. In 2009, he joined the Board and immediately made meaningful contributions. He was an integral contributor during my year as President in 2010, including strongly supporting my efforts related to the District Architecture Center as an outspoken advocate. David was an effective communicator and consistently worked to build consensus on issues before the Board and was never reluctant to assist with committee assignments and tasks. In addition to his leadership positions, including as 2013 Chapter President, he chaired the Design Excellence Committee, Honors Committee, and has been an active member of the Fellows Committee since his elevation to the College of Fellows in 2012. David is known by all to be a natural leader and a thoughtful participant, and many Board members, including myself, sought – and continue to seek - out his advice and thoughts before acting on a given matter.

Upon joining the Board, David immediately took on chairmanship of the Design Excellence Committee and started the highly successful *Washington* UNBUILT awards program. He expanded the Design Excellence Committee from essentially two members – the Executive Director and a Board member – to an active group of 30 to 40 members who met, and continue to meet, monthly to select juries for design awards programs, run other programs, sponsor occasional lectures, and to discuss the state of design and factors that influence design for our members.

One of David's highpoint activities as a Board Member was as a Co-Chair of the Chapter Host Committee of the 2012 AIA National Convention held in Washington DC. In addition to his organizational activities, David was committed to elevating Washington DC as a critical region for serious design dialogue. As anyone involved with the convention knows, his tasks required a monumental amount of time and effort over several years to pull off, and the success of our convention is one of the testimonies to his efforts.

The Washington DC region has three active AIA Chapters. While geographically close, they have unfortunately often acted independently and at times at cross-purposes. Recognizing this issue, David instigated and led efforts during his service on the AIA|DC Board to enhance communication and integrate activities of these Chapters. He was a co-founder of the Custom Residential Architects Network (CRAN) Tri-Chapter Committee, an effort that created a stronger more active committee which continues to be a benefit

to members involved in that market. As a newly elevated Fellow in 2012 and as Chapter President in 2013, David led an initiative allowing members of the adjacent Chapters to participate in the AIA|DC Fellows Committee program that supports member preparation of submittals to the College of Fellows. Many of David's other initiatives continue to this day, have inspired new efforts, and have added value and opportunities to our region and the members of all three Chapters.

Another one of David's meaningful contributions to the Chapter has been his active ongoing mentorship of emerging and mid-career architects and designers. He enthusiastically participates in programs focused on mentorship and is a frequent speaker at national and local AIA events on the practice of architecture and on the process associated with becoming a Fellow. David has mentored and sponsored numerous candidates for Fellowship and has led outreach efforts to women and minority candidates. David has also been exceptionally generous with his financial support of mentorship and emerging architect's programs and scholarships. Typical for David, when I approached him about an effort to create a Fellows scholarship endowment he responded with - "how can I help" - and immediately became a founding contributor.

In addition to his service to the profession, David also contributes to his community. His leadership activities extend to related professional, academic, cultural and community organizations. David currently financially supports and serves as a trustee of The National Building Museum, the DC History Center, and the University of Virginia Architectural Alumni Foundation. David continues to be an active supporter for diverse leadership on these boards, and has recruited women, persons of color, and members from associated professions.

For the past six years, David has been a Trustee of the Cosmos Club Historic Preservation Foundation. In 2021, he was elevated to President of the Foundation Board and is currently leading an extensive restoration to the historic Townsend House, a national historic landmark. I serve as an advisor to the Foundation (at David's invitation) and can personally attest that much like his other activities, he has consistently advocated for active leadership in stewardship for the property and brought a tireless effort to this task which will help preserve an important piece of Washington's architectural history.

An engaging leader, David attracts and inspires colleagues to engage in volunteer activity, pro bono work and social responsibility by his own example, from civic and professional leadership to urban programs, such as the DC Initiatives Manager for the Capital Impact Partners. An advocate for the architect's role as a civic leader, he spreads the word through university graduate programs, research and lectures, national and regional forums, and AIA sponsored events. David is a sought-after design critic, and a frequent lecturer and panelist on current architecture and practice at regional universities, and at national and local conferences. Both in the local universities and through AIA|DC initiatives, David participates in portfolio critiques, and often works with individual students to improve their presentation of their work to attract greater attention as they seek employment.

An active alumnus of the School of Architecture at the University of Virginia, David has supported the Dean's Forum with significant contributions for over twenty years. David was asked to become a member of the School's Architectural Alumni Foundation where he actively engages in fund raising for the Foundation, as well as advocating for critical issues. David teaches course segments on professional practice, serves as a critic for design and thesis juries, provides externships and internships to students, and remains a strong advocate for the expansion of the existing facilities to provide facilities commensurate with student and faculty needs, and with the School's standing as a top tier institution.

His contributions to the profession and the community also include those made through his professional work. David was a founding partner of Bonstra | Haresign ARCHITECTS in Washington, DC. Established in 2000, the firm is well known for its work that revitalizes communities, especially in emerging neighborhoods, and is often inserted into historic neighborhoods. David's work successfully engages a spectrum of

community issues and goals. Committed to smart growth planning and preservation, David promotes affordable housing as a basic right - retaining less affluent residents in old neighborhoods and housing them in new ones. He has designed and implemented more than 110 individual buildings as well as multi-building masterplans for non-profit developers and community organizations including AHC, Wesley Housing, and Melwood. His successful practice also is a role model for diversity. The firm embraces a diversity of team members, with over 60% of the members with minority and/or international backgrounds, and nearly 50% female design professionals.

In summary, it is an honor to write this nomination letter that only touches on the surface of the career of an architect that has made a meaningful and lasting contribution. His many leadership activities have elevated the profession and demonstrated how architects can better their communities. I believe David is worthy of this award and recognition and trust the jury will give him thoughtful consideration.

With 45 years of professional experience, David Haresign, FAIA is a widely recognized leader of the Washington region's design community. As a founding partner of Bonstra | Haresign ARCHITECTS in Washington, DC, David fosters and leads a studio of talented professionals who are engaged in AIAIDC's regional professional community. Established over 20 years ago in 2000, the firm is well known for its work that reinforces communities and catalyzes emerging neighborhoods. Award-winning work led by David, in a wide range of typologies and scales, has garnered over 115 national, regional and local awards, and has been published in international, national and local books, magazines, newspapers and digital media. He has built a very successful practice that embraces diversity, with over 60% of the team members with minority and international backgrounds, nearly 50% female design professionals <a href="https://www.bonstra.com/">https://www.bonstra.com/</a> **studio/people/**, and with diverse partners outside of the firm designing and implementing the work.

David led AIA|DC as President (2013), as an officer on the Executive Committee (2010 – 2014), as board member (2009-14), and as 2012 National AIA Conference Host Chapter Committee co-chair (2010 - 2012). As former chair (2009-12) and member of AIA|DC's Design Excellence Committee, David champions inclusive, well-juried Chapter awards programs. David was elevated to the AIA College of Fellows in 2012, and since 2013 has been a key member of the Chapter's Fellows Committee. He represents AIA|DC locally and nationally, with publication in Architect magazine news, panel discussions, and events such as AIA's 2021 virtual Conference.

David supports an allied community of cultural, civic, and academic organizations, and engages many more local and regional communities of people and interests. Complementing his firm and AIA pro bono work, David serves the related cultural and academic communities. He is a trustee of the National Building Museum, the DC History Center, and the University of Virginia Architectural Alumni Foundation. Through his suggestions and recruitment, all three organizations have diversified their boards. He is also the 2021 President of the Cosmos Club Historic Preservation Foundation. David is a sought-after design critic and a frequent lecturer and panelist at academic juries and conferences. David attracts and inspires colleagues to volunteer, take on pro bono work, and

embrace social responsibility - a classic illustration of leadership by example. He continues his efforts as a role model and as a mentor of emerging and mid-career architects and designers.

In his practice David focuses on complex, large-scale projects, with a characteristic openness to community issues and goals. Long committed to smart growth planning and neighborhood preservation, David increasingly seeks the practical achievement of residential mixed use and the basic right of affordable housing—whether keeping less affluent residents in their older neighborhoods, or making them part of new ones. A co-creator of over 110 mixed use and multifamily designs, David is currently planning, designing and implementing master plans and buildings for such non-profit and community-based organizations as AHC, Wesley Housing, and Melwood.

"David's practice model engages and inspires everyone, from students and interns to emerging architects, mid-career architects, and peer colleagues within the practice of architecture and to stakeholders outside of the profession," writes Professor Barry Yatt, FAIA.

David's involvement with the AIA has grown from initial membership upon registration to leading panels related to professional practice and as an entrant and periodic winner of the Chapter's design awards programs to leadership of AIA|DC, The Washington Chapter of the American Institute of Architects. He is a recognized among National leadership and Institute administration, has campaigned to elect several AIA Presidents, and frequently enters into productive policy dialogue with elected leaders and the Executive Director. Following are a few of David's accomplishments:

### AIA|DC Board Service (2009 - 2014)

With a strong interest in giving back to the profession and serving the local AIA membership, David was elected to the Board as an At Large member. He immediately began leadership as Board liaison to and committee chair of the Design Excellence Committee (DEC) and encouraging a new center for architecture as headquarters for AIA|DC (see below). His immediate contributions to the Chapter and to President Elect Steven Spurlock earned David fast track advancement to nomination as an officer and member of the Executive Committee in 2010. David then advanced the Chapter's early planning efforts for the upcoming 2012 National AIA Convention in Washington (see below). David helped the Chapter to successfully navigate the Convention, and the Chapter earned a cash infusion from the National AIA that offset revenue loss caused by the convention.

In 2013 immediately after the 2012 AIA National Convention, David became Chapter President – a year of recovery and reset for the Chapter. Some of David's accomplishments include:

- Working closely with Executive Director Mary Fitch, Hon, AIA, AICP, and the board, David led an increase in member involvement through engagement in committees based on the belief that active members are more committed to the organization. AIA|DC has expanded from 5 committees to over 17 active committees; committee leadership now meets together to cross-pollinate and create joint programming. David helped lead a strategic plan
- David specifically encouraged expanded advocacy, led by eventual board member and 2017 AIA|DC President Carolyn Sponza, AIA, LEED AP with now Bonstra | Haresign ARCHITECTS Associate Partner Jack Devilbiss, AIA, LEED BD+C.
- David worked to increase collaboration and engagement among the three local AIA chapters, and to establish cooperative agreements with other professional organizations, such as IIDA, American Society of Landscape Architects, and the American Planning Association. The connections resulted in joint planning for courses at DesignDC and joint participation in events increasing cross-disciplinary attendance.
- Collaborating with Helen Wilkes, AIA (the originator), David worked the AIA Potomac Valley
  Chapter and with Randy Mars of AIA Northern Virginia founding a tri-chapter Custom
  Residential Architects Network (CRAN), a strong component of a national organization within
  the AIA. CRAN provides learning and networking opportunities to small-scale the majority
  of AIA member firms.
- David encouraged AIA|DC board member Sean Stadler, FAIA (thought leader and originator), to implement the Christopher Kelley Leadership Development program. David introduced Sean to Ryan McEnroe, AIA, ASLA, LEED AP. Sean and Ryan established the program, which is now active in nine other AIA chapters, with significant annual interest for additional programs (see below). The program trains and nurtures the next generation of leaders. The curriculum focuses on core professional skills such as entrepreneurship

and firm management, working together and collaboration, the art of negotiation, client development, community leadership, industry trends, and developing your future within the practice. In 2018 at AIA Grassroots, the AIA|DC CKLDP was recognized with the recognized with the AIA CACE Component Excellence Award for Knowledge Sharing Initiatives.

"I first met David as a graduate student at the University of Virginia 12 years ago. He has since been a great professional mentor, and has made a profound impact on my development as a young architect. He continually make's time to support the next generation of architects. With David's encouragement and support, the Christopher Kelley Leadership Development Program (CKLDP), now in 9 different AIA components, I joined Sean Stadler, FAIA to create the program."

  - As David took on increased duties for the Convention and the AIA|DC Chapter Presidency, he encouraged Steve White, FAIA, to assume leadership of the Design Excellence Committee.
  - David worked with Sean Nohelty, AIA, who David had recruited to become a Design Excellence Committee member 2014 AIA|DC President, to reimagine the annual awards dinner. Sean and his cohort established the Design Fete to celebrate AIA|DC Great People and Design Excellence, with attendance that eventually grew from approximately 150 attendees to over 300.
  - David has actively mentored new chapter leaders, encouraging committee participation and leadership. Sean Nohelty, AIA (2014), Steve White, FAIA (2015), Sean Stadler, FAIA (2016), and Carolyn Sponza, AIA (2017) were all encouraged to join the AIA leadership., and advanced to become President of the Chapter.

### District Architecture Center (2009 – 2012)

David was a leader in establishing **AIA|DC's District Architecture Center (DAC)**, at the time the largest AIA "storefront" outreach center in the U.S., and the new, downtown headquarters for both the Chapter and the allied Washington Architectural Foundation. Among David's contributions and results:

- Retained fund raising consultant, personally raised over 8% of the project's costs
- Set an aggressive schedule that enables the DAC to open in time for the 2012 National Convention
- Led programming, including visits to comparable U.S. architecture centers, research on lessons learned
- Located, secured the visible, Metro-accessible location on D.C.'s 7th Street arts and entertainment corridor
- Advocated an open design competition and recruited competition adviser Roger Lewis,
   FAIA, resulting in 17 entries and a well-received winning design

"I served on AIA|DC's taskforce promoting a more effective 21st century AIA, and giving it a public face. With the economy in shambles and approval in doubt, David Haresign made a strong and eloquent plea to the boards of the AIA|DC and the Washington Architectural Foundation to finalize our plan, begin fundraising, develop a program, conduct a design competition, and pursue an aggressive schedule for the District Architecture Center (DAC.) ### AIA|DC Design Excellence Committee (2009 - Present)

As a new Board member David Haresign re-organized the Design Excellence Committee, expanding it from a committee of one to over 30 active Chapter members, and achieving the following results:

- Originated and implemented a new awards program Washington UNBUILT
  - Showcase both commissioned and theoretical unbuilt projects of all design disciplines – architecture, planning, landscape architecture, interiors, and objects, creating an outlet for designers during construction slump
  - Engage the local university design community, giving students and faculty opportunities to participate on equal footing with practitioners, and strengthening their ties to the AIA
  - **UNBUILT** attracted over 100 entries, and netting the Chapter up to \$10,000 annually
  - In the early years, the announcement of winners has nearly tripled attendance to the opening party at DesignDC (AIA|DC regional conference)
- Refined, expanded the Jury pool list
- Established jury criteria that resulted in greater diversity in gender, race, typology expertise, polemic, and geographic location of practice, improving and broadening jury composition
- Recruited leaders in the AIAIDC chapter and other allied professions
  - Senior Leaders Don Meyer, FAIA, Les Shepherd, FAIA, Former Dean Garth Rockcastle, FAIA, Lewis Goetz, FAIA, FIIDA (co-chair), Chris Graae, FAIA, Gerry Briggs, FAIA, Mark Strauss, FAIA, J.P. Spickler, FAIA, Amy Gardner, FAIA, Robert Miller, FAIA, Jon Fitch, ASLA and other respected senior leaders to participate as long time committee members. These leaders significantly add to the conversation about the awards program, especially related to definitions of the awards program, and selection of outstanding jurors
  - Mid-career professionals Sean Nohelty, AIA, Steve White, FAIA (co-chair), Devon Perkins, AIA, and Michael Day, AIA (co-chair) with passion about design, and advancing the quality of our awards programs and celebratory events
  - Young professional Marek Hnizda, AIA (secretary, co-chair, B|HA), Tanya Ally, AIA (secretary, co-chair, B|HA), David Polk, AIA and Jeffrey Rynes (secretary) learning the value of service to the profession and receiving leadership training

- Added Planning and Urban Design as a category to the Chapter Design Awards program
- Refined written submission criteria
- Converted all three Chapter awards programs to digital submissions, resulting in reduced submission costs, more sustainable resource use, and a ready-made digital archive

### AIA|DC Fellows Committee

Since his elevation to The College of Fellows in 2012, David joined the AIA|DC Fellows Committee in order to give back to the Committee, to encourage and support deserving candidates to consider applying for Fellowship, and to assist interested members to achieve Fellowship by providing constructive guidance and feedback on submissions. For the past ten years, David has attended over 90% of the monthly meetings, and provided additional direct critique to submitters with direct discussions. Starting in 2013, David has successfully sponsored eight Fellows – respected friends and colleagues – and written reference letters for many other successful applicants. David has spoken as a panelist at **DesignDC** at the request of Fellows Committee Chair, Janet White, FAIA, and initiated a "Meet the Fellows" introductory program to celebrate newly elevated Fellows. David continues to advocate for greater diversity within the Fellows community, encouraging qualified colleagues and friends to apply, and sponsoring, coaching and writing reference letters for these candidates.

### **District Architecture Exhibits**

David organized and chaired two major, highly successful exhibits at the District Architecture Center focusing on AIA|DC member architects' impact on the city – reVISION::THINKING BIG and reBIRTH::Washington, DC 50 Years after 1968. In addition to organizing the teams, David participated in content development, procured photographs and models, worked directly with the graphic designer, content writer, video producer and gallery manager to create the exhibits that were each displayed in both galleries of the District Architecture Center. David also organized and raised much of the funds needed to produce the exhibit materials and to stage opening ceremonies. Both exhibits were also displayed at other venues.

### Ongoing Mentorship:: from Committee Leadership to Organization Presidents

David lives by the rule that a good leader always trains his or her replacement. David identifies talented and intelligent people to fulfill critical roles, confirms commitment and willingness to serve, invests time, and shares knowledge. In organizations like AIA|DC, mentoring the next generation of leaders leads to continuity and a long-term organizational stability and success. Both from within his firm and in the course of transacting professional engagement, David successfully engages and recruits for committees, events and leadership. Within AIA|DC, David recruited and mentored the four chapter presidents who succeeded him – Sean Nohelty, AIA (2014), Steve White, FAIA (2015), Sean Stadler, FAIA (2016) and Carolyn Sponza, AIA (2017). David has encouraged and coached colleagues and friends to contribute to the richness of AIA|DC by joining and leading committees. From within Bonstra | Haresign ARCHITECTS, David has recruited the following team members: Jack Devilbiss, AIA, LEED AP (Advocacy, chair), Marek Hnizda, AIA (Design Excellence Committee, secretary, Washington UNBUILT leader, co-chair), Tanya Ally, AIA (Design Excellence Committee, secretary, co-chair), Joseph McKinley, (Emerging Architects, vice chair), Tensae Woldesellasie (Advocacy), Zenairee Garcia, AIA, LAIDEA.

David's concern for the social, community-centered design - a necessary dimension of collaborative integrated practice - includes the workplace communities shown above and draws no hard line between non-profit and for-profit projects. That said, work shown in this section focuses on examples that highlight community issues and interests: affordable housing, diversity of residents and uses, sustainable urban and land use design and extended life of historic and other existing resources. Representing a variation on this theme are Haresign's projects for transforming office campuses into diverse, walkable urban villages. David Haresign's 60 or more mixed income/mixed use residential designs are represented by recent examples. As with his workplace projects, these have often had impact both in terms of client and community outcomes (for instance the community- catalyst effect of Parker Flats at Gage School) and influence in the professional and building community. Innovations include:

We represent three organizations—University of Virginia School of Architecture Alumni Foundation, the National Building Museum, and the DC History Center—that have each benefited from David's commitment to community service and dedication to his profession, particularly by expanding opportunities in the architecture and design field for women and people of color.

We see David's steadfast volunteer leadership as truly exemplary and his role as a civic leader deserving recognition at the highest level. Collectively, we have known David for over 95 years.

David has served as Trustee of the University of Virginia School of Architecture Foundation Board since 2016. As his immediate four successors as President of the Chapter, we have been witness to- and direct beneficiaries of- David's unparalleled commitment to the cultivation, mentorship, and development of the next generation of leaders. It is through David's steadfast and selfless work over several decades in developing future leaders that he ensures the work of the Chapter in service to our members, our profession, and our community carries on.

Each of us first met David through our affiliation with the Chapter during our early-to-mid-career years. He strongly encouraged us to actively participate in a committee and engage with our colleagues in the work of the Chapter in advancing and elevating the profession. As Chair of the Design Excellence Committee (among his other leadership positions), David led by example in showing us, and all committee members, the way to develop and articulate a strategic vision, build consensus among a diversity of views, and act decisively upon key initiatives. All along the way, he served as our mentor in helping develop our professional skills, foster our unique interests, and climb the ladder of leadership in his footsteps, all with his enthusiastic support.
